#### 1.0 Introduction

- 1.1 I refer to my most recent Circular to Creditors dated 3 December 2015.
- 1.2 As you are aware, I was appointed Liquidator of the company on 9 July 2014 pursuant to a resolution passed by the shareholders of Venture Personnel Pty Ltd ("the company") to place the company into Creditors' Voluntary Liquidation.
- 1.3 The purpose of this report is to provide an update on the progress of the liquidation in accordance with Section 508 of the Corporations Act 2001 ("the Act").

#### 2.0 Receipts & payments

2.1 Annexure A sets out the receipts and payments in the liquidation of the company to date.

#### 3.0 Asset realisations

- 3.1 Please refer to my Circular to Creditors dated 4 February 2015 for a summary of the asset realisations. There have been no further realisations to date.
- 3.2 I note that I am currently pursuing a pre-appointment debt in the sum of \$27,208.

#### 4.0 Priority creditors

- 4.1 As you are aware, a former employee of the company has made an application for leave of the Court to commence and proceed with an action for damages against the company in respect of a workers compensation claim.
- 4.2 The company's insurer has assumed conduct of this matter and intends to indemnify the company, pursuant to the employer's indemnity policy held by the company.
- 4.3 I note that this matter is still ongoing and there is a possibility that the former employee may have a claim against the company (for an amount, if any, not covered by the company's insurance policy).

#### 5.0 Unsecured creditors

- 5.1 To date I have received ten formal claims totalling \$822,594 from unsecured creditors.
- 5.2 Please find attached a Proof of Debt form. I encourage creditors who have not already lodged a Proof of Debt with me to do so as soon as possible.

#### 5.3 Electronic notification to creditors

Section 600G of the Corporations Act 2001 permits electronic notification to creditors of certain notices or documents. If you would like to nominate to receive electronic notification, please complete the relevant section on the Proof of Debt or Claim form enclosed.

#### 6.0 Dividend

6.1 As advised in my Circular to Creditors dated 3 December 2015, it is still likely that a dividend will be paid to unsecured creditors once the matters outlined at Paragraph 3.2 and Section 4.0 are resolved. I will notify creditors accordingly in due course.

### 7.0 Liquidator's remuneration

- 7.1 Fees incurred in the liquidation for the period 9 July 2014 to 30 June 2016 are \$92,983.50 (excluding GST). See Annexure B.
- 7.2 The total Liquidator's fees approved by creditors is \$98,739.70 (excluding GST), calculated at follows:

7.3 To date, I have drawn fees of \$90,858.50 (excluding GST).

### 8.0 Annual General Meeting

- 8.1 Pursuant to Section 508(1) of the Act, if a creditors' voluntary winding up continues for more than one year, a Liquidator must either convene an Annual General Meeting or prepare a report and lodge it with ASIC.
- 8.2 As there are no resolutions to be voted on by creditors, I have decided not to convene an annual meeting of creditors pursuant to Section 508(1)(b)(i) of the Act.
- 8.3 In fulfilling my obligations as Liquidator of the company under Section 508 of the Act, I will lodge a copy of this report with ASIC.
